NOTIFICATION

No.GLR.(RC)82/2012/87.- Whereas the draft of certain rules further to amend the Assam Factories Rules, 1950 hereinafter referred to as the principal Rules were published as required under Section 115 of the Factories Act, 1948 (Central Act 63 of 1948) in the Assam Gazette Extraordinary No. 309, dated 3rd November/2015 followed by Corrigendum published in the Assam Gazette Extraordinary dated 6th April/2016, vide respective Notification Nos. GLR(RC)82/2012/29, dated 14th September, 2015 and GLR(RC)82/2012/83, dated 3rd March, 2016 respectively, inviting objections or suggestions from all persons likely to be effected thereby till the expiry of a period of 30(thirty) days from the date of publication of the Notification in the Official Gazette.

And whereas no objections or suggestions were received by the Governor from any person in respect of the Draft Rules before the expiry of the specified period;

Now, therefore, in exercise of the powers conferred by section 112 of the Factories Act, 1948 (Central Act 63 of 1948), the Governor of Assam is hereby pleased to make the following Rules further to amend the principal Rules, after having been published previously as mentioned hereinabove, namely :-

- Amendment of rule 6 3. In the principal Rules, in rule 6, in sub-rule (4), for the words "hundred rupees", the words "five hundred rupees" shall be substituted.
- Amendment of rule 7 4. In the principal Rules, in rule 7, in sub-rule (4), in the proviso, in the last line, after the word "licence", the following words and figures shall be inserted, namely:-
"Subject to a minimum amount of Rs 500/-(excluding licence fees)".
- Amendment of rule 8 5. In the principal Rules, in rule 8, in sub-rule (3), for the existing words "hundred rupees", the words "thousand rupees" shall be substituted.
- Amendment of rule 10 6. In the principal Rules, in rule 10, in for words "hundred rupees" the words "rupees two thousand" shall be substituted.
